1. Subject

2. Duration

3. School Obligations

- a) Act in good faith in the relationship with the Guardian and the enrolled student;
b) Comply fully with the Terms and Conditions set forth herein;
c) Include in its payment system the reduction of tuition fees where the requirements for this are met.

4. Obligations of the Parent

- a) To ensure that the enrolled student attends school assiduously, demonstrating good behavior and manners;
b) Pay the fees within the deadlines established by the school;
c) Provide the address of the place of residence upon submission of a Neighborhood Declaration;
d) Update the school in the event of a change in data or place of residence, e-mail address, and mobile phone contact, and it is one's responsibility the of such an obligation;

5. Teaching Material

- a) It is the responsibility of the school to assign books from the Cambridge system and, it is the responsibility of the parent in conserving them;
b) In case of damage, destruction, or loss of property belonging to the school, the responsibility is solely and exclusively of the Guardian, and the parent must replace it immediately or proceed to the payment of the amount corresponding to the cost of the respective property.

6. Acceptance of the Terms and Conditions

- a) Acceptance of these Terms and Conditions is subject to the signature of this document by the Guardian.
